Professional Development Emphasis

Based upon these findings, the Florida Department of Education through the Just Read, Florida! Office has initiated a state-wide professional development series to teach teachers how to review text to ensure it sufficiently complex to sufficiently challenge students.

In addition, Just Read, Florida! has developed a comprehensive staff development series, the Comprehension Instructional Sequence (CIS) to assist teachers in teaching students to think as they read through complex text in all subject area. Additionally, Content Area Professional Development has been revised to align with the findings of the ACT study and text complexity.

has been predominantly secondary. Since NAEP assesses 4th and 8th grade, I think the PD emphasis should be tailored to grades leading up to these, for a document that is suggesting PD emphasis based on NAEP results, don't you?
