Cari,

Another statute that might help is 1012.55 which Veronica White sent my way. In the first paragraph it says:

(1) The State Board of Education shall classify school services, designate the certification subject areas, establish competencies, including the use of technology to enhance student learning, and certification requirements for all school-based personnel, and adopt rules in accordance with which the professional, temporary, and part-time certificates shall be issued by the Department of Education to applicants who meet the standards prescribed by such rules for their class of service. Each person employed or occupying a position as school supervisor, school principal, teacher, library media specialist, school counselor, athletic coach, or other position in which the employee serves in an instructional capacity, in any public school of any district of this state shall hold the certificate required by law and by rules of the State Board of Education in fulfilling the requirements of the law for the type of service rendered. Such positions include personnel providing direct instruction to students through a virtual environment or through a blended virtual and physical environment. The Department of Education shall identify appropriate educator certification for the instruction of specified courses in an annual publication of a directory of course code numbers for all programs and courses that are funded through the Florida Education Finance Program. However, the state board shall adopt rules authorizing district school boards to employ selected noncertificated personnel to provide instructional services in the individuals' fields of specialty or to assist instructional staff members as education paraprofessionals.

Thanks for your thorough response. This captures all of my knowledge on this subject as well. As I mentioned to Laurie, it has always been my understanding that certification requirements are driven through our course code directory. I can see the references in State Board Rule, but I am also unaware of any statutory requirements.

Cari -

This additional State Board Rule provides a little more information:

6A-1.0503 Definition of Qualified Instructional Personnel.

A qualified instructional person is defined as an instructional staff member who meets one (1) of the following conditions:

(1) Holds a valid Florida educator's certificate with the appropriate coverage as provided for in the Course Code Directory as adopted by reference in Rule 6A-1.09441, F.A.C., or...

Cari,

State Board Rule 6A-1.09441 pertains to the course code directory and says this:

The rule requires that school-level, district-level, and postsecondary-level personnel use this directory when performing the following tasks:

- (1) scheduling students into any PreK-12 course
- (2) aggregating student assignments for course data
- (3) identifying courses which may be used to fulfill graduation and program completion requirements
- (4) determining appropriate certification for specified courses.

The directory says this for reading:

No Child Left Behind Act of 2001

The No Child Left Behind Act of 2001 (NCLB) places a major emphasis on highly qualified teachers. This new federal law establishes requirements for determining if a teacher meets the criteria for being reported as "highly qualified" under NCLB. It is important to note that current Florida Statutes and State Board of Education Rules relating to the classification of teachers reported for Florida purposes as "infield", "qualified", or "out-of-field" are not the same as the new federal highly qualified designation requirements. Thus, a teacher may be considered "infield" pursuant to the requirements of the Course Code Directory but will not be classified as a highly qualified teacher in the NCLB reporting.

In order to meet the requirement of NCLB for highly qualified teachers, the following changes in certification coverages will be effective on July 1, 2006.

Reading

K-6 or 1-6 will remain the appropriate coverage to teach reading at the elementary or middle school (6th grade only) level. In order to teach a reading course at the middle school (with the exception of a 6th grade elementary education certified teacher teaching 6th grade reading to sixth graders) or high school level subsequent to June 30, 2006, a teacher must be certified in reading or carry the reading endorsement on the certificate. The reading endorsement may only be added to a certificate that reflects a Bachelor's degree or higher.

Certification in Primary Education K-3 and Prekindergarten Primary PK-3 may also be appropriate coverages at those grade levels.

Reading Certification Requirements for Exceptional Student Education (ESE) Teachers

Grades K-6: The elementary ESE teacher must meet the highly qualified requirements for an elementary education teacher. If the ESE teacher meets the highly qualified requirements of a general education elementary teacher, then the ESE teacher also meets the highly qualified requirements for reading, grades K-6. An ESE teacher certainly can go beyond this requirement and obtain the reading endorsement or reading certification.

Also, the statute pertaining to certification can be found here: <http://www.fldoe.org/committees/pdf/FS-1012-56.pdf>. It doesn't refer to reading in particular, but rather references the certification requirements in general.

The legislation – 1003.4156 & 1003.428 says the following:

For each year in which a student scores at Level 1 on FCAT Reading, the student must be enrolled in and complete an intensive reading course the following year. Placement of Level 2 readers in either an intensive reading course or a content area course in which reading strategies are delivered shall be determined by diagnosis of reading needs. The department shall provide guidance on appropriate strategies for diagnosing and meeting the varying instructional needs of students reading below grade level. Reading courses shall be designed and offered pursuant to the comprehensive reading plan required by s. 1011.62(9). A high school student who scores at Level 1 or Level 2 on FCAT Reading but who did not score below Level 3 in the previous 3 years may be granted a 1-year exemption from the reading remediation requirement; however, the student must have an approved academic improvement plan already in place, signed by the appropriate school staff and the student's parent, for the year for which the exemption is granted.

There is no reference to the qualifications of the teacher; however, there is no reference to the qualifications of teachers who teach other courses that are referenced in the statute either. For instance, it is required that students complete courses in science, social studies, etc. but it is not mentioned in this statute that the teachers must be certified to teach the courses. I would think this would be assumed and it is covered by the Course Code directory rule.

I sent a message to Veronica White in the Certification office to see if she knows of any statute that I'm not aware of. I hope this helps!

Thank you so much. Are you saying that there is NO law that requires the reading endorsement for secondary teachers teaching specified courses listed in course code directory??? Maybe a course code directory law, or certification law.

Actually, after review of intervention rule, could it be
Middle School: 1003.4156, F.S
High School: 1003.428, F.S.

Or is it just the reading intervention RULE that requires it:

(g) One of the following courses as listed in the Course Code Directory incorporated in Rule 6A-1.09441, F.A.C., must be used to provide reading intervention to all middle school Level 1 students and those Level 2 students not being served through a content area reading intervention course (all courses require Reading Endorsement or Certification in Reading (Grades K-12):

- . 1000000 M/J INTENSIVE LANGUAGE ARTS
- . 1000010 M/J INTENSIVE READING
- . 1000020 M/J INTENSIVE READING & CAREER PLANNING
- . 1002181 M/J DEVELOPMENTAL LANGUAGE ARTS THROUGH ESOL (Reading)
- . 7810020 READING: 6-8

Cari,

I've attached the new reading endorsement rule. The course code directory indicates the certification needed for each course provided. We incorporated the names of the reading intervention courses in the Reading Intervention rule, and the teachers of those courses are delineated in the course code directory as needing to be reading certified or endorsed. Also statute 1011.62 addresses other teachers who teach reading in their content areas: The plan format shall be developed with input from school district personnel, including teachers and principals, and shall allow courses in core, career, and alternative programs that deliver intensive reading remediation through integrated curricula, provided that the teacher is deemed highly qualified to teach reading or working toward that status.

Please let me know if you need anything else – sorry it took some time to get this to you ☺

I'm not sure exactly what you're looking for...I can tell you that the EPI's send folios to the Bureau of Educator Recruitment, Development, and Retention (Tonya Jones & Eileen McDaniel) and then they are forwarded to us for review. If an institution provides Reading Endorsement courses solely to a district to use for inservice points and not college credit, then those folios are sent directly to us. If they are using the courses as part of the EPI program then they go to Tonya & Eileen and then to us. We will be working with colleges and universities as well as EPI programs to provide guidance as they update their Reading Endorsement courses to incorporate the new competencies and indicators. Do you have any specific questions?
