Hazing suspected in FAMU student's death

Friends remember Champion's hard work, dedication

Shawn Turner, a drum major in the Florida A&M Marching 100, said Robert Champion exemplified everything it meant to be a drum major.

"He was very ambitious," Turner said. "He worked for everything — from 5 a.m. until the work was done and he was never late. A perfect gentleman."

Small wonder Champion's fellow drum majors gave him the name "The Example."

As a few drops of rain finally began to fall after a cloudy day, students, band alumni, musicians and professors made their way into the Lee Hall Auditorium for a vigil Tuesday evening in honor of Champion, who died Saturday at the age of 26.

Space was limited; the first floor of the auditorium was completely full. Few students were able to hold in their emotions as friends, band director Julian White and university President James Ammons paid tribute to a fallen Rattler.

"The 100 is better because he was one of us," White said. "The community is better because he lived among us."

White reminded those who attended to say things they need to say to loved ones before they are gone. He said Champion was meant to be next year's head drum major and White missed the chance to tell him before he died.

"If you love someone, tell them now," he said. "If you need to say something, say it now. I didn't know when I spoke to him it would be the last time I talked to him."

Emotions at the vigil ran high. People excused themselves despite ushers moving throughout the auditorium with tissues. One man was ushered out by his friends, sobs drowning out their words of comfort.

Prayers and stories brought tears to the eyes of those who came to honor the memory of Champion, but the musical selections were punctuated by audible sobs from the crowd. Three selections were played and all three received standing ovations from the crowd.

Alysia Boles sang with FAMU's Concert Choir and also gave remarks about Champion. One thing she said she would truly miss was Robert's ability to always give her a genuine smile and a wink in passing.

"God has gained a true and mighty champion," she said to the crowd after her solo. "An earthly king. A knight in shining armor."

Diron Holloway, a professor of music at FAMU, said it was "truly a pleasure" to be Champion's teacher, as Champion was always looking to improve his skills.

For two hours the rumors and allegations of hazing surrounding Champion's death took a backseat to the process of honoring the man he was. Hazing was mentioned only once throughout the vigil when Ammons promised to completely remove hazing from the university.

"These allegations of hazing make my heart hurt even more," he said. "No parent should have to worry about hazing on a college campus."

Students gathered around the Eternal Flame on campus and joined hands in prayer after the vigil was over. Turner said filling the void left by Champion will take time. He and Champion both came to FAMU with dreams of becoming drum majors, he said.

"He wasn't like a brother," Turner said. "He was a brother. He will be missed very much. After going through three- and four-adays together, seeing someone all the time, and now you can't see them at all? It's hard."

Suspending Marching 100 may be only the start

This is no time for alibis, no time for hard-to-keep promises, no time for warnings.

The death of a Florida A&M Marching 100 drum major, a death that late Tuesday was officially attributed to hazing, calls for action. It is a tragedy and an extremely dark hour for this university.

FAMU President James Ammons on Tuesday made a bold move in what no doubt will be a long and painful process when he suspended the Marching 100 band indefinitely. He also, for the time being, called an end to all performances associated with the FAMU Department of Music.

Drum major Robert Champion died Saturday in Orlando, after performing at the Florida Classic football game. Though the Orange County Sheriff's Office initially said foul play was not suspected, investigators came to Tallahassee on Monday as part of their effort to determine the cause of death. Rumors and social media had fueled speculation about hazing, a fact that could only have exacerbated the pain and shock of Mr. Champion's family in Atlanta.

Hazing has been a particularly stubborn part of the Marching 100 culture for more than a halfcentury. The late band director William P. Foster once said it dated back to at least the 1950s. Over the years, there have been hospitalizations, suspensions, criminal charges and lawsuits resulting from hazing in the band. This semester alone, 30 band members were suspended for involvement with hazing — a fact that was not part of Dr. Ammons' prepared remarks at Tuesday's media briefing but was confirmed, after a reporter's question, by director of bands and department chair Julian White.

Dr. Ammons vowed Tuesday that he would "make certain that we end this practice at Florida A&M University." But obviously, not enough has been done to root out this barbaric practice.

How could the president not have known or been told about those 30 suspensions?

The immediate suspension of the Marching 100 shows that Dr. Ammons means business — though, for the moment, the move, while dramatic, is mostly symbolic. Florida A&M's football season is over and the band has no performance engagements scheduled.

Beyond symbolism, Dr. Ammons said he would create an independent task force to fully investigate the Marching 100.

Though the task force should include representatives from FAMU, Dr. Ammons must be careful to keep it independent of the Music Department or alumni.

Its effectiveness must not be compromised by old-school loyalty, finger-pointing or the idea that the band itself is sacrosanct.

Dr. Ammons has even tougher decisions to make. The Marching 100 has been a source of pride and an important part of the identity of not only Florida A&M but indeed our entire community. Yet if the band is shown to be utterly corrupt and if hazing has continued to be tolerated as part of its culture, a long-term suspension and the dismissal of the band's leaders — to cut out the disease — may well be the only answer.

This is not one of Florida A&M's prouder moments. On Tuesday, Dr. Ammons showed he has the will to face a problem head-on and deal with it, no matter how difficult that might be. It's a time for the students, alumni and community to give him their support. It's a battle he won't be able to win alone.

Florida School District Denies Police Were Called Over Student Kiss

FORT MYERS, Fla. – A Florida school district on Tuesday dismissed reports that an administrator called police after two 12-year-old students shared a kiss on the playground.

According to reports Monday, two female students were debating who liked a 12-year-old boy more when one of the girls walked over and kissed the boy. Lee County Sheriff's deputies were dispatched to Orange River Elementary School in Fort Myers, Fla., reportedly in response to the incident.

However, a statement issued by the school district Tuesday said authorities were "not called because one student kissed another on the cheek."

According to the statement, there was a "physical altercation" between two female students that prompted an investigation by authorities. During the investigation, a "separate, non-school related situation" was uncovered that required police and officials with the Florida Department of Children and Families (DCF) be contacted.

"Our school leaders are experienced enough to know that one elementary school student kissing another on the cheek is not grounds to call police," the statement said.

"This school's administration did exactly what they were supposed to do and what every parent would expect – and demand – they do as school leaders," it added.

Earlier reports suggested that the administrator had initially contacted DCF to report the kiss.

"They called us and said they caught two children kissing on the playground," Sgt. Stephanie Eller told Fox News Radio. "The reality is it was probably something innocent between two kids on the playground."

Eller said the deputies took a report and documented the incident, but determined no crime had been committed.

"If it had been a crime at all it would have been a simple battery," Eller said. "The battery consists of the unwanted touching of one person to another."

"At this point, it doesn't look like we have anyone who was an unwilling participant in this," she said, referring to the playground smooch.

Eller said no one was arrested and that she suspected the school was being overly cautious.

Joe Donzelli, a spokesman for Lee County Public Schools, had told the Naples News that school district employees are required to call DCF if they suspect abuse.
