Cari,

Thank you for your message. My Thanksgiving was terrific and I hope yours was the same! Regarding the 2007 standards - the only other effort there was at the time was in the course specific tracks that JRF provided – Kevin and I did try to emphasize the 2007 standards in the midst of those tracks. However, if you remember, nearly as soon as the 2007 standards were adopted, legislation was passed that required DOE to revisit those standards and use the “Next Generation” process. This was done, and the 2009 version of the Language Arts standards was developed – but before they could be adopted, talk of the Common Core began, so the 2009 version was tabled. I think that a large scale rollout/PD was never implemented for the 2007 standards because of the legislation that required us to go back and revisit them. Does that make sense?
