Essentially, these were created at a point-in-time using membership data, which can be found for previous years here <http://www.fldoe.org/eias/eiaspubs/pubstudent.asp> under the "Archives" link at the top. For those reports where the percentages are missing, you can find the appropriate denominator in the files posted in the archives titled "School Membership by Grade, 200X-XX". For the 2010-11 school year, they are waiting on two school districts to finish their quality assurance process. I did not receive an ETA on how long that might take.

In regards to the appropriate place to find data, I'm more than happy to assist in tracking down requests. For good cause exemption information, the program office linked above produces these reports and can be reached through askeias@fldoe.org. Let me know if there's any other assistance I can provide.
