Slide 1: we would like to update data on the percentage of Students Reading at Grade Level or Higher in FCAT Reading for

2002 cohort represents the year before retention policy

2003 cohort represents the 1st class under retention policy

2004 cohort represents the 2nd class under retention policy

Slide 2: update with 2009-10 (and 2010-11 data if already available) the percent of high school graduates who pursue postsecondary education (public or private) in the fall immediately after graduation

Slide 3: what percent of high school students are not graduating solely because of the FCAT (last year we determined it was 8%, there was a far greater percent that did not graduate, but those that did not graduate, only 8 percent had met all the other requirements, but just had not met the FCAT requirement).

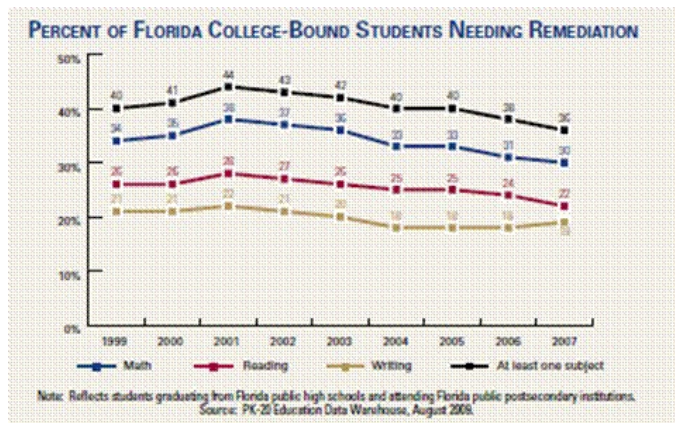
