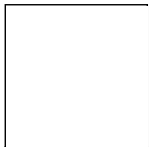

On September 29-30, 2011, the Florida Department of Education will conduct meetings to gather input from state school district, business, and organization leaders on the establishment of achievement standards for the FCAT 2.0 Reading, Mathematics, and the Algebra 1 End-of-Course (EOC) Assessment. Because of your leadership in Florida, you have been nominated to serve on this important committee, referred to as the Reactor Panel. The meeting will take place at the Hotel Duval in Tallahassee, Florida, from September 29–30, 2011.

Prior to this meeting, committees of Florida educators will have made recommendations for these standards by considering the nature of the test questions, the difficulty of the items, and the potential impact on students. This committee will review and provide feedback on these educator recommendations for the achievement level standards and the impact of these proposed standards on students.

Registration for the meeting will occur on September 29 at 7:30 a.m., with the meeting beginning promptly at 8:30 a.m. Please plan to arrive on schedule, as the agenda will be full and each item on the agenda is critical to the success of the overall process. Breakfast will be available each day from 7:30 to 8:30 a.m. The meeting will begin promptly each day at 8:30 a.m. and will conclude by 5:00 p.m. on September 29 and 2:00 p.m. on September 30. Lunch will be provided each day.

Travel, hotel, meals, Internet, and parking costs will be paid directly by Pearson or reimbursed after the meeting.
