Greg:

It was great to see you at the ECS meeting in Denver. This is a follow-up of our conversation about reading and the poor FCAT scores of our public school children. I would like to have the Dean of the College of Education contact me concerning assigning a Doctoral student to work with NEFEC/PAEC and the DOE to develop a research design for a reading program that is currently being funded by the Florida Legislature.

On Monday there is a presentation on the project with Dr. Joe Lockavitch... We need a researcher to develop a match pair research designed evaluation of the program that is being presented to show the results of the program even though there have been 10 published research studies on this program already.

We invite you and the UCF Dean to log in to learn about a special Legislative appropriation that is funding this non-phonics, language development-based reading intervention for the lowest literacy high school students, including DJJ youth.
