Yes they could do that, but NO they are not required for submission to the state. Districts may require that they keep their documentation, but it probably varies greatly. ESE monitors would ask for it if they were conducting on-site visits to review individual student records for compliance. That's it...the rest is up for team's to decide. No one at DOE to my knowledge enforces or inspects the PMP requirement directly.
