There is only one year of data collected for NGCAR-PD. Statistics for the 2008 school year show data for teachers that were completing the CAR-PD rather than "has completed" it. We think this report responds to your request [for CAR-PD & NGCAR-PD] but if not let us know.

The staff in the data warehouse are working on the grade 3 data request along with a data query on From the first year of implementation to 2011, number/percent of Reading Endorsed or "certified in Reading" teachers in each district.

#### Reading Endorsement/CAR-PD

- ✗ From 2000-2011, number/percent of active Reading Endorsed or "certified in Reading" teachers in each district, grades 6-12 student outcomes as measured by FCAT by district?
- ✗ From first year of implementation to 2011, number/percent of CAR-PD'd teachers in each district, grade 6-12 student outcomes as measured by FCAT by district?

1. From 2000-2011 number/percent of active reading endorsed or certified teachers in each district, grades 6-12 with student outcomes as measured by FCAT. The data warehouse does not pull the data element pertaining to reading endorsed teachers, so while they can connect students with teachers in the intensive reading courses, they cannot verify that the teachers have completed or are in the process of completing the reading endorsement.
2. From first year of implementation to 2011, number/percent of CAR-PD teachers in each district, grades 6-12 with student outcomes as measured by FCAT. The completion of CAR-PD or NGCAR-PD is noted within the data element pertaining to reading endorsement. Therefore, the same issue exists with content area reading intervention courses. Students can be connected with teachers, but they cannot verify the teachers have completed or in the midst of completing CAR-PD or NGCAR-PD.

Also, flags for reading intervention courses (intensive reading and content area reading courses) did not exist before 2007. Reports can be run from 2007-2011. Finally, the reports will encompass grades 6-10 to reflect data on the students taking FCAT. Data will need to be pulled from the year 2007 and forward as that is when we started flagging students for reading intervention. The information we need to gather should reflect the following: **The number/percent of active reading endorsed or certified teachers in each district, grades 6-12 with student outcomes as measured by FCAT and the number/percent of CAR-PD teachers in each district, grades 6-12 with student outcomes as measured by FCAT.**

I have attached two sample spreadsheets - one for reading intervention and one for content area intervention that reflect a layout of what we need to know. For intensive reading teachers, Andre's team should pull the data for students enrolled in one of the following courses for reading intervention: '1000000','1000010','1000400','1000410','1008320','1008010','1008020','1008040','1008050','1008070','1008080','1008300','1008310','1008330','7810020','79100100','7910400','1002180','1002380','1000020'.

For content area teachers they will need to pull information for students marked with a "y" for reading intervention but not enrolled in one of the courses listed above. They may need to work with School Grades or Juan Copa to help them integrate the information regarding reading endorsement, certification, or ~~OPAR~~. This is not something the data warehouse has available to them.
