This is what I requested - cut and pasted from what I gave to Pam and Loretta on Feb 6.

Funding

(probably easiest to get from grants management - all we need is the original grant approval form - we don't need the amounts granted to each district within one pot of money)

* From 2000-2002, federal or state money given to JRF or Curriculum/Instruction (under Don Greisheimer/Bo Elzie) for reading, either for statewide activities or for grants to districts, consortia or universities

* From 2002-2012, federal or state money given to JRF for reading - either for statewide activities or for grants given to districts, consortia or universities

And as a follow up email to Loretta on 2/23, I said this:

I need to be responsive to the Commissioner - I am fine calling Martha Asbury directly on the funding information I requested. If I need to send someone over there to go through the paperwork, I can.

And then yesterday morning, I emailed this to Stu:

For the pre-2005 information, I am happy to come over and look through the filing cabinet in the JRF office - all I need for those years is the original grant approval form - I don't need any district allocations or state appropriation information - I have the proviso from each year's budget that tells me that. What I want is the funding source (federal and state) for the grants we gave 2000-2005 before the JRF office was formed, and then through 2005. What I want to examine is the source of the federal discretionary funds we used to start projects like FOR-PD and the initial grant to FCRR, and the Research-based Reading Grant, etc.

But anyway...here is what I need:

2002

An rfp for Research-based reading grants - 3 million in federal discretionary funds. I don't need who was awarded, or the rfp. I just want that first page of the grant - or maybe even the pre-approval that identifies the funding source.

An rfp for the Florida Center for Reading Research. Stu sent a scanned copy of a nce from that project - but not the original. I attached it.

An rfp for the Online Professional Development course (awarded to UCF) for 2 million in existing federal funds.
