We have received a request for Chiefs for Change to support a letter from the Children's Defense Fund to Congress re: ESEA. The letter is very short and crisp and falls completely in line with the Chiefs' guiding principles for ESEA reauthorization.

The Children's Defense Fund is urging congress to make sure **all students and all schools are part of the accountability system.**

They would like to send this letter prior to your next bi-weekly call, so we are asking for your input/approval via email.

We would recommend that you do sign on to this letter, since the mix of the other supporters (ACLU, Center for American Progress, NAACP, etc.) provides a very good, different mix of the entities you have aligned with in the past and we recommend that Chiefs for Change sign on as a group (vs. individual members).

Jaryn:

Thanks for your quick response. I've attached the letter. We are on a bit of a tight turn-around, hoping to get sign-ons by the end of the day next Thursday (7/21). The development of this letter grew out of a meeting hosted by Marian Wright Edelman with a number of education advocates to discuss concerns about the accountability issue in ESEA reauthorization. Given that a number of leaders in the education reform, civil rights, and business communities have already commented on accountability, our goal is to bring together a diverse group of organizations to sign on.

You'll see that the letter is short and to the point, delivering the message that a revised accountability framework in ESEA reauthorization must include all schools and all students, and that proposals limiting accountability to the lowest-performing schools are unacceptable. As I mentioned already, we think the letter is very much consistent with the principles for ESEA reauthorization that Chiefs for Change released in May.

Sign-ons so far include the Children's Defense Fund, ACLU, Center for American Progress, the Education Trust, the Leadership Conference on Civil and Human Rights, and the NAACP Legal Defense Fund. Again, we are hoping to get sign-ons by **next Thursday, July 21st**—and would be happy to work with you to get any other information needed to the chiefs. We'd really love to have the group sign-on.
