Dear members of the State Board of Education,

I won't be appearing at your workshop on school grades tomorrow. However, I wanted you to know that the Foundation supports the department's recommended changes to the school grade calculation. I'm available by cell if you have any specific questions – 850-443-1290.

Also, I wanted to invite you to a press conference on Tuesday at 11:30 in the 301 Capitol. The Foundation is holding a press conference with Senate President Mike Haridopolos, Ben Austin with Parent Revolution, our bill sponsors Sen. Lizbeth Benacquisto and Rep. Mike Bileca, former Sen. Al Lawson and other stakeholders. The press conference is on the parent empowerment bill. The bill does primarily two things: 1) creates a parent trigger – similar to California's law that gives parents the ability to direct school boards to select a specific turnaround differentiated accountability option and 2) it ensures no child is assigned to an ineffective teacher two years in a row.

I've attached a short white paper on the legislation.

HB 1191- Parent Empowerment by Rep. Bileca and SB 1718 by Sen. Benacquisto

The Foundation for Florida's Future asks that you vote **YES** on HB 1191/SB 1718 in the House K-20 Innovation Subcommittee/Senate Budget Subcommittee on PreK-12 on January 24th.

HB 1191/SB 1718 recognizes that parents should be empowered to ensure their child receives a high quality education. - ☀️ Allows democracy to prevail. When the majority of parents unite and sign the petition, their voice is heard.
- ☀️ Increases parental awareness and involvement in schools.

Insist on High Quality Teachers

- ☀️ Students cannot be assigned to an "unsatisfactory" or "needs improvement" teacher 2 years in a row.
- ☀️ Guarantees every child receives a highly effective or effective teacher at least every other year.
